

Number of Deals by U.S. Sponsors, 2005 - 2016



There were 15,854 transactions worldwide by U.S.-based buyout firms with a total disclosed valuation of about \$2.1 trillion from January 1, 2005 through February 19, 2016. From this tally, 2,356 transactions took place in the high technology industry and those with reported financial details combined for about \$265.7 billion.

Deal Volume by U.S. Sponsors, 2005 - 2016 (US\$B)



Within the U.S.-based High Technology industry, the Software sector (39.6 percent) took up the majority of the deal space, accounting for 932 of the 2,356 transactions from 2005 to 2016. IT Consulting & Services came in second with 454 deals (19.3 percent) and the Internet Software & Services sector placed third with 388 deals (16.5 percent).
