There were 15,691 transactions worldwide by U.S.-based buyout firms with a total disclosed valuation of about \$2.0 trillion from January 1, 2006 through August 10, 2016. From this tally, 2,215 transactions took place within the Consumer Products & Services industry and those with reported financial details combined for about \$135 billion.





Within the Consumer Products & Services industry, the professional services sector led the way, accounting for 1,220 of the 2,215 transactions (55.2 percent) from 2006 to 2016. Second was other consumer products with 479 deals (21.7 percent), while home furnishings came in third with 164 deals (7.4 percent).
