
INSIGHT: LBO Activity in Healthcare



There were 16,350 transactions worldwide by U.S.-based buyout firms with a total disclosed valuation of about \$2.0 trillion from January 1, 2006 through November 20, 2016. From this tally, 1,429 transactions took place within the Healthcare industry and those with reported financial details combined for about \$137 billion.

Within the Healthcare industry, the Healthcare Providers & Services (HMOs) sector led the way, accounting for 677 of the 1,429 transactions (47.4 percent) from 2006 to 2016. Dropping off in second was Healthcare Equipment & Supplies with 440 deals (30.8 percent), while Pharmaceuticals came in third with 134 deals (9.4 percent).
