

INSIGHT: LBOs in Canada

The following tables reflect closed LBO deals by U.S. buyout firms in all of Canada. The source for the data is Thomson One, a product of Thomson Reuters. Please contact Paul Centopani at pcentopani@buyoutsinsider.com with questions or comments.



There were 15,980 transactions worldwide by U.S.-based buyout firms with a total disclosed valuation of about \$1.3 trillion from January 1, 2008 through January 16, 2018. From this tally, Canada was responsible for 745 transactions and those with reported financial details combined for about \$52.8 billion.



Within the deals made in Canada by U.S. LBO firms, High Technology led the way with 186 of the 745 transactions (25 percent) from 2008 to 2018. Industrials placed second, accounting for 135 deals (18.1 percent), while Consumer Products and Services and Materials tied for third with 75 deals each (10.1 percent).
