
There were 16,136 transactions worldwide by U.S.-based buyout firms with a total disclosed valuation of about \$1.4 trillion from January 1, 2008 through February 19, 2018. From this tally, High Technology was responsible for 2,643 transactions and those with reported financial details combined for about \$245 billion.

Within the deals made in the High Technology industry by U.S. LBO firms, Software led the way with 1,076 of the 2,643 transactions (40.7 percent) from 2008 to 2018. IT Consulting & Services placed second, accounting for 567 deals (21.5 percent), while Internet Software & Services came in third with 378 deals (14.3 percent).
